- Statement of the Government Authorithy (if applicable, see section 5)

You cannot make any changes or additions to a submitted application, even if the fellowship application deadline has not yet passed. Note, that Nuffic will use the contact details to inform you about your scholarship application. It is your explicit responsibility to fill out this application form correctly and attach the necessary documents.
