11. Summary of the new findings of the thesis:

In requirement of judicial reform nowadays, the thesis is the first comprehensive study on implementation of imprisonment in our country, is shown in the following specific content:

- Thesis systematized and analyzed in theory on implementation of imprisonment which introduces the concept, features, content and principle of imprisonment.
- The thesis studied systematically enforcement history in general and criminal enforcement of imprisonment in particular from 1945 to the present. The thesis specifies the differences in this activity in the period, different stages of development, allowing us to draw the lessons of experience and on that basis, have the orientation, the specific measures appropriate to the enforcement activities of imprisonment current and future.
- The thesis analyzes and assesses the content of regulation on implementation of imprisonment through Penal Code, Code of Criminal Procedure and Law on implementation of criminal imprisonment.
- The thesis studied foreign regulation on implementation of imprisonment which compares with Vietnam's regulation. The thesis also assesses the foreign advantage which Vietnam can apply.

- Thesis has presented the requirements and basis in order to improve the efficiency of enforcement of imprisonment; improve the direction of efficiency of imprisonment, offering complete legal and organizational solutions on imprisonment...

- The thesis has brought a breakthrough solution in the current situation is the statutory "*early release with terms and conditions*".

12. Paratical applicability, if any:

- To contribute to the implementation of Party resolutions on judicial reform in the field of enforcement of imprisonment.

- The content and results of the thesis can be used as references in service of research, teaching and learning in legal education institutions and police school.

- The dissertation proposals have practical implications for the conduct of amending and supplementing the Code of Criminal Procedure 2003 and and Law on implementation of criminal imprisonment as well as the law on the organization and operation of the competent authorities in enforcemen of imprisonment, proposed measures to strengthen the organization and operation of such bodies.
